1. Introduction and summary

The Nordic Payments Council ("NPC") is responsible for the development and maintenance of the NPC Schemes. This is done according to the NPC Scheme Management Internal Rules.

The 2020 NPC Credit Transfer Scheme Rulebook is the first NCT Rulebook to be published. A proposal of the Rulebook (NPC001-01 version 0.99) was issued for public consultation on June 13th, 2019. An invitation to all identified stakeholders was sent out with a request to answer before September 6th, 2019.

All comments have been analysed by the NPC Credit Transfer Working Group ("NCTWG") and by the Scheme Management Committee ("SMC").

This document summarizes all the comments received and presents the result per comment.

This document contains for each comment:

- a) Comment title
- b) A description/summary of the comment;
- c) The NCTWG analysis of the comment and recommendation to the SMC;
- d) The SMC decision, based on the NCTWG analysis and recommendation

As a result of the 2019 NCT Public Consultation process, the 2020 NCT Rulebook has been updated to include the changes presented in this document.

2. Overview of comments submitted for the 2019 Public Consultation

All comments to the 2020 NCT Rulebook have been reviewed by the SMC and the NCTWG.

This section lists the comments from all responders received by the NPC.

2.1 Possible recommendations for a comment

Each recommendation reflects one of the options detailed in points a) through f) below:

- a) The comment is already provided for in the Scheme: no action is necessary for the NPC
- b) The comment **should be incorporated into the Scheme**: the comment becomes part of the Scheme and the Rulebook is amended accordingly



- c) The comment **should be included in the Scheme** as an **optional feature**:
 - The new feature is optional and the Rulebook will be amended accordingly;
 - Each Scheme Participant may decide to offer the feature to its customers, or not.
- d) The comment is **not considered fit for Nordic-wide use and could be handled as an additional optional service (AOS)** by interested communities:
 - The proposed new feature is not included in the Rulebook, nor in the Implementation Guidelines released by the NPC related to the Rulebook;
 - The development of AOS is out of scope of the NPC. However, the NPC does publish declared AOS arrangements on the NPC Website for information purposes;
 - The NPC may consider the inclusion of AOS arrangements, if supported by a sufficient number of communities, in a future version of the Rulebook;
- e) The comment **cannot be part** of the Scheme:
 - It is technically impossible or otherwise not feasible (to be explained on a case by case basis);
 - It is out of scope of the Scheme;
 - It does not comply with the SEPA Regulation, or any other relevant EU, Nordic or Swedish legislation.
- f) The comment request may be considered for the development of a **new scheme**:
 - The comment reflects major changes which cannot be integrated into an existing scheme;
 - To develop the comment further, i.e. to develop a new scheme, the following requirements should be met;
 - The benefits of the new scheme for payment end users are demonstrated prior to the launch of the development phase;
 - It is demonstrated that a sufficient number of stakeholders will make use of the new scheme;
 - A cost-benefit analysis is provided;
 - It complies with the SEPA Regulation or any other relevant EU, Nordic or Swedish legislation.



2.2 Summary of comments and results following the public consultation

The table below summarizes all comments and commenters. The comments have been categorised into major and minor comments. All the major comments have a detailed description, NCTWG analysis and recommendation and SMC decision in chapter 4. The minor comments are detailed with decision in chapter 5.

In addition to the comments from the Public Consultation, the SMC has also decided that the NCT Rulebook shall support additional general and editorial changes proposed by the NPC. These are found in section 4.3. Some of the changes were due to the fact that the Rulebook will be governed by Swedish law.



3. Detailed analysis of major comments and SMC decision

This chapter details all the major comments with the NCTWG analysis and recommendation as well as the SMC decision. Note that two comments have been considered especially important and have been analysed by the SMC.

3.1 **#CT02 Included original references in a repaired Credit Transfer Instruction**

This comment was made by BITS.

The comment is regarding section 4.3.2.2 and CT-01.03R "Any instruction that is repaired and re-sent by the Originator Bank shall be deemed to be a new Credit Transfer Instruction under this Rulebook". BITS states, that it is important that the new instruction includes one of the references in the original Credit Transfer Instruction, initiated by the Originator (for example "End to End Id"). An NPC rule in the Implementation Guidelines could define and specify this.

3.1.1 NCTWG analysis and recommendation

The NCTWG recommends this comment to be included (**option b**) in the 2020 NCT Rulebook by adding the wording "Transaction references must be reused from the original message" to CT-01.03R.

Further, it has been verified that this is included and described in the Implementation Guideline for interbank messages (NPC Credit Transfer Scheme Interbank Implementation Guideline).

3.1.2 SMC decision

For inclusion in the 2020 NCT Rulebook (option b).



3.2 #CT03 Fee from Beneficiary bank for recall message

3.2.1 Description

This comment was made by BITS.

The comment is regarding fees charged by the Beneficiary bank for sending recall message when a credit transfer instruction (pacs.004) is sent to an incorrect account number, referred in section 4.3.2.3. Even though the wording is in accordance with the SEPA Rulebook, BITS are missing reference to agreed fee regime, or a bilateral agreement, so that both parties will know the cost.

3.2.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option e**) in the 2020 NCT Rulebook.

As stated in the Rulebook, the Beneficiary Bank has the possibility to charge a fee for sending a recall message back to the Originator Bank – when a payment instruction is sent to an incorrect account number. An agreement to determine such fees is allowed to be between the parties - but if such an agreement is made or not is out of scope of this Rulebook and NPC as an organisation.

3.2.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (**option e**).



3.3 #CT05 Reachability and Opt-Out

3.3.1 Description

This comment was made by Sveriges Riksbank.

The comment is regarding reachability and the so called opt-out option described in section 2.6. All Participants need as a minimum to be reachable domestically in one of the currencies covered by this Scheme with the option to accept cross border transfers. This means that there is a possibility to opt-out of cross border payments.

Sveriges Riksbank does not support the statement about reachability in section 2.6. If a participant is reachable in one currency, Sveriges Riksbank believes that the participant should be mandated to accept all transfers from all other participants in that currency, regardless of whether it is a domestic or cross border payment.

3.3.2 SMC analysis and recommendation

The SMC recommends this comment to be included (option b) in the 2020 NCT Rulebook.

The SMC has decided that the so called opt-out option needs to be defined and described more in detail. The SMC has after analysis reached the conclusion that the opt-out option must be included in the NCT Rulebook in order not to exclude potential participants. There are participants in current Nordic payment and clearing systems that are allowed this choice today. Forcing them to accept cross border payments is considered to be an unproportionate requirement.

The SMC agreed to rephrase the wording in section 2.4 third bullet to: "All Participants need as a minimum to be reachable domestically in one of the Scheme Currencies covered by this Scheme with the option of <u>not</u> accepting Cross-border Credit Transfer Transactions, if the Participant only participates in one of the Scheme Currencies. As a consequence of opting out from receiving Cross-border Credit Transfer Transactions, the Participants will not be allowed to send Cross-border Credit Transfer Transactions". Additional changes in section 1.2 first bullet and 1.7 third bullet.

3.3.3 SMC decision

For inclusion in the 2020 NCT Rulebook (option b).



3.4 #CT08 Additional receipts

3.4.1 Description

This comment was made by Bankgirot regarding additional receipts.

The comment is referring to figure 3: Credit Transfer Process in section 4.3.1. Bankgirot sees that the process does not include any receipts. Bankgirot thinks that the process should be enhanced with additional receipts. In this way, it can be established that the receiver has indeed received the message. Bankgirot sees that receipts give certainty in the status of the payment and mitigates the risk for payments not being processed according to instruction from Originator.

3.4.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option e**) in the 2020 NCT Rulebook.

This comment is regarding additional receipts or positive acknowledgement. The Rulebook should be considered a framework and a conceptual document containing business rules with only "minimal requirements" (e.g. the Rulebook states the need of rejecting acknowledgement).

The Rulebook is not a technical specification and shall not cover all possible details for a technical implementation, since the Rulebook shall not limit, nor apply, detailed solution to participants, nor to other parties (for example a CSM). Furthermore, the Rulebook does not limit the use of positive acknowledgement. However, this - as well as other possible technical messages - is a possibility for a CSM to implement and offer, if a CSM decides to do so. Hence, any services could provide any receipts from CSM.

3.4.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (option e).



3.5 **#CT09** Time requirements for Reject messages

3.5.1 Description

This comment was made by Bankgirot.

The comment is referring to the last paragraph in section 4.3.2.1. Bankgirot states that the requirement regarding the time line for 'Reject' messages is set too low. For the Originator, it is often important that the payment is processed on the requested payment date to avoid costs and other problems due to delayed payments.

With reject messages received one day later, Bankgirot thinks that the services to the Originators would not be as good in the future as it is today. Therefore, Bankgirot proposes a prompt message, so that the Originator has the possibility to send a new payment instruction on a same day basis.

3.5.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option e**) in the 2020 NCT Rulebook.

The Rulebook states that a reject message should be sent on a same day basis, when possible. However, the Rulebook defines the minimum requirements - which is stated as sending a reject message one day later. However, it is still possible for the CSM to have additional rules (e.g. country specifics).

3.5.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (option e).



3.6 #CT10 Forward Originator alias or proxy

3.6.1 Description

This comment was made by Bankgirot.

This comment is regarding the possibility to forward the Originator's alias or proxy from the Originator Bank to Beneficiary Bank to give opportunities for enhanced services to customers.

3.6.2 NCTWG analysis and recommendation

The NCTWG recommends this comment to be included (option b) in the 2020 NCT Rulebook.

A new attribute AT-11 "Alias or Proxy of the Originator's account" is added. By adding the attribute "Alias or Proxy of the Originator's account" (AT-11), the Rulebook fulfils the requirement to support a number of existing alias- or proxy services. The reason for including the additional attribute in the interbank messaging is to allow the alias or proxy, used by the Originator, to be used by the Beneficiary Bank in order to supply alias or proxy in communication with the Beneficiary, if the alias or proxy service requires it.

"The Alias or Proxy of the Originator's account (Optional)" (AT-11) is added to DS-02 and DS-04. Since it is currently not stated in the Customer-to-bank dataset which attributes are optional, "The Alias or Proxy of the Originator's account" is added to DS-01 (i.e. not market as optional).

3.6.3 SMC decision

For inclusion in the 2020 NCT Rulebook (option b).



3.7 #CT13 Pointers/references to external sources of ERI information

3.7.1 Description

This comment was made by CGI.

The comment is regarding pointers/references to external sources of ERI information in section 2.7. CGI mentions, that the current chosen standard in the Rulebook for ERI does not support pointers/references to external sources of ERI information. CGI means, that it seems like the model chosen is to carry all ERI information within the payment message. Since the society in general is striving to get more data to support an even more automatic way of carrying out various business processes, CGI thinks it would be an advantage to attach also more ERI data to the payments. For instance, by adding a reference to an external source (to avoid having a large payment message).

3.7.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option d**) in the 2020 NCT Rulebook.

This comment may be addressed in newer updated EPC Rulebooks and ISO versions. The NCTWG suggests that NPC, through the normal EPC change management process, suggests this as a possible change to the EPC.

3.7.3 SMC decision

Not to be included in the 2020 NCT Rulebook (**option d**).



3.8 **#CT15** Warehousing for CSM

3.8.1 Description

This comment was made by CGI.

It is regarding warehousing for CSM. CGI is referring to section 4.2 and interprets the Rulebook as if there is a concept of "no warehousing" in the CSM, i.e. any potential warehousing is done by the Originator Bank before sending the payment of to the CSM (if the Originator has indicated a future value date). If this is the case, CGI thinks it is a little bit difficult to read this out of the current phrasing is the Rulebook. CGI proposes a clarification.

3.8.2 NCTWG analysis and recommendation

The NCTWG recommends no change to the 2020 NCT Rulebook, since this is already provided for in the Scheme (**option a**).

The Rulebook is a framework and does not limit warehousing, i.e. the Settlement Date of the NPC Credit Transfer (AT-42) can be a future date. It is up to each CSM to decide if warehousing is supported and, if so, decide on how many future business days credit transfers can be submitted to CSM.

3.8.3 SMC decision

The comment is already provided in the 2020 NCT Rulebook (option a).



3.9 #CT16 TIME field from Originator

3.9.1 Description

This comment was made by CGI.

The comment proposes a change in the message from Originator, in which a TIME field is added. CGI sees that having a "TIME" field would add value since the Originator (and later on the Originator Bank) could indicate at which time during the day the payment should latest arrive to the Beneficiary. CGI understand that this will increase the complexity within the bank, but still sees it as likely that this type of "control" will be sought after in by many customers, and therefore CGI thinks it would be good to include it into the Rulebook.

3.9.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option e**) in the 2020 NCT Rulebook.

This feature is not in scope of the NPC to decide. This is possible to handle as part of agreements between the actors outside of the NPC Schemes. It could be handled by interested parties as an AOS.

3.9.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (**option e**).



3.10 #CT22 Which version of ISO 20022 standard is being used?

3.10.1 Description

This comment was made by BOKIS.

The comment is regarding which ISO 20022 standard the Rulebook has the intention for participants to make use of, the 2009 or the 2019 version. In addition to this, BOKIS mentions that the Implementation Guidelines refer to the 2009 version.

3.10.2 SMC analysis and recommendation

The SMC has analysed whether an upgrade to ISO 20022 2019 version from the current ISO 20022 2009 version should be done. The SMC has decided to keep the reference to the 2009 version, thereby adhering to the vision of NPC following as closely as possible the EPC SCT, in which the Implementation Guidelines refer to the 2009 ISO version.

3.10.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (**option e**).



3.11 #CT24 Rulebook clarification to Mandatory Customer-to-Bank (C2B) Implementation Guidelines (IGs)

3.11.1 Description

This comment was made by BOKIS.

The comment is regarding section 0.5.1 in which the Rulebook handles the NPC Credit transfer Scheme Implementation Guidelines. BOKIS wonders why the use of Credit Transfer Scheme Customer-to-Bank Implementation Guideline is mandatory (binding) on request and proposes that this should be out of scope for the NPC to decide. The suggestion is that the Customer-to-Bank Implementation Guideline is not mandatory (binding) on request.

3.11.2 NCTWG analysis and recommendation

The NCTWG recommends this comment to be included (option b) in the 2020 NCT Rulebook.

The NCTWG has analysed the consequences of the C2B IG referred to as binding (mandatory). There is no regulation in the Nordics equivalent to the SEPA Regulation, which is the legal basis of the EPC Rulebooks handling euro. The NCTWG view is that the NPC cannot impose an obligation regarding Customer-to-Bank Implementation Guidelines on the potential participants of the NPC Credit Transfer Rulebook without the risk of making it an unproportionally obstacle for potential participants to adhere to the NPC Credit Transfer Rulebook. Making the Implementation Guideline binding (mandatory) might be in conflict with the right of proportional access to payment systems. There is a risk of excluding potential participants that are participants in national domestic clearing today.

However, the NCT WG recognized an advantage of having the C2B IG binding (mandatory) in the future and the NCT WG therefore suggests revisiting this issue in the next change management cycle of the NPC Credit Transfer Rulebook.

Changes are made in section 0.5.1 and 4.5.1 (DS-01) to reflect the recommendation. In section 5.7 bullet 15 was removed. The definition in chapter 7 has been updated.

3.11.3 SMC decision

For inclusion in the 2020 NCT Rulebook (option b).



3.12 #CT25 Definition of reachability

3.12.1 Description

This comment was made by BOKIS.

The comment is regarding section 2.4. BOKIS questions whether the definition regarding reachability is accurate when the rulebook states "All Participants need as a minimum to be reachable domestically in one of the Scheme Currencies covered by this Scheme with the option of accepting cross border transfers."

The question from BOKIS is whether the definition be that all participants as a minimum should be reachable in their domestic currency.

3.12.2 NCTWG analysis and recommendation

After dialog with BOKIS, it was identified that this comment is regarding the same area as comment #CT05. Please see section 3.3 (#CT05) for NCT WG analysis and SMC decision.



3.13 #CT31 Clarification of Banking Business Days

3.13.1 Description

This question was made by BOKIS.

The question is regarding how participants will count banking business days, since all participants are not using the same calendar. Which country calendar must participants follow?

3.13.2 NCTWG analysis and recommendation

The NCTWG recommends this comment not to be included (**option e**) in the 2020 NCT Rulebook.

There are market practices in each jurisdiction on which days are Banking Business Days. This will be handled in practice by the CSM and outside of the NPC.

3.13.3 SMC decision

The comment cannot be a part of the 2020 NCT Rulebook (**option e**).



4. Minor comments and SMC decision

The NPC Secretariat has identified certain minor changes which it considered necessary for the NCT rulebook. Further, some minor comments were submitted during the Public Consultation.

4.1 Comments from Public Consultation where NCT Rulebook has been changed

The SMC has decided that the NCT Rulebook shall support the following minor comments from the Public Consultation, presented in the table below:
