Information public consultation

- The public consultation ended February 1st, 2022
 - 9 responses to the NCT Rulebook
 - 8 responses to the NCT Inst Rulebook

Based on incoming responses, NCT & NCT Inst WG changed their recommendation for:

- #CT01/INST01 Mandatory C2B Implementation Guidelines
 - From option b (include in the scheme) to option e (cannot be part of the existing scheme)
- #CT06 Fast Payment Processing 24/7/365 Option
 - From option c (include in the scheme as optional feature) to option d (not considered fit for Nordic wide use and could be handled as an additional optional service (AOS) by interested communities)

NPC and Request-to-Pay

Request to make a payment - used for example in einvoicing, e-commerce & Point of Sale

- The NPC's mission is to facilitate payments in the Nordics and interoperability with the euro-zone
- EPC SRTP Scheme version 2.0 is currency agnostic meaning that payments in the "Krona" currencies can be requested according to the same common Rulebook as euro
- NPC published clarification report for EPC SRTP in end of January - <u>NPC Clarification Report on EPC SRTP</u>
- The NPC RTP working group analyses and agrees Nordic positions as input to the EPC SRTP work.

The EPC SRTP Scheme will be used for the Nordics as well - creating harmonisation within the Nordics and towards the euro-zone.
