Process for NPC Membership and Scheme Adherence

The time for NPC Scheme Adherence is pending the **readiness date***


- At least 6-8 months prior to the readiness date, apply for NPC Membership**
 - Application sent to the NPC, <u>available on NPC web-site</u>
 - NPC verify that the eligibility criteria (which equal to the NPC Scheme criteria) are fulfilled
 - Possibly additional information is needed
 - Approval decision at a NPC Board meeting (4-5 times per year), complete application need to be at the NPC
 2 weeks prior to a Board meeting. Board meeting schedule is available on the NPC web-site.
- Approved Members to be added on the NPC web-site
- 3-4 months prior to the readiness date, apply for NPC Scheme adherence
 - Application sent to the NPC, <u>available on NPC web-site</u>
 - Possibly additional information is needed
 - If nothing has changed in the applicant's status, no Board decision is needed.
 - The Secretariat to approve the application
- Approved Scheme participant to be added in the participant register on the NPC web-site with its scheme readiness date

* readiness date – the date when the applicant is in a position to comply with all of the obligations set out in the Rulebook(s).

** NPC membership applications can be made at any time, preferably before the NPC Scheme Adherence application and at the latest at the same time




6. Follow up publication 2023 version

- NCT & NCT Inst Rulebooks published June 20th according to plan
- Implementation Guidelines (IG) published later, July 11th
 - Received draft from EPC late
 - NPC will publish IGs on MyStandards during autumn
- To consider for next change cycle:
 - Challenge to align with EPC we do not get drafts from EPC
 - Need more time after EPCs publication not possible to have the same publication date as EPC

Information public consultation Confirmation of Payee

- The public consultation ended August 15th, 2022
- Public consultation documents published on NPC's website under <u>Public</u> <u>Consultation 2022 - Confirmation of Payee</u>:
 - NPC050-01 2022 NPC Confirmation of Payee Rulebook v0.9
 - <u>NPC Consultation Comments Template</u>
- The NPC encouraged all Stakeholders to respond, NPC wants to make sure to align with the markets needs. Even an answer acknowledging the receipt of the consultation stating that there are no comments would be much appreciated.
- The NPC received 6 responses, 24 comments in total
- NPC received several requests about the draft Implementation Guidelines
- NPC will present the incoming responses in a public consultation result document





Ongoing work Confirmation of Payee

- 6 responses have been received, 24 comments in total
- No major changes suggested by the market
- NPC CoP WG will analyse and make recommendations
- Setterwalls have made 2 legal opinions (general and competition law)
- LSG will make a final review and statement
- Stakeholder Forum position paper
- SMC decision November 24th to publish Confirmation of Payee Scheme



Stakeholder Forum position paper

- The Stakeholder Forum has a formal task to make a position paper on Confirmation of Payee Rulebook
- Suggestion to make a small task force to draft the Position Paper to be sent out to Stakeholder Forum for review
- Prior to Stakeholder Forum meeting November 17th comments need to be provider to NPC
- Stakeholder Forum need to agree on the position paper November 17th
- A document describing the result of the Public consultation and CoP WG recommendations will be sent out.
 - NPC055-01 NPC CoP Rulebook 2022 Public Consultation Change result document
- Decision in SMC will be taken November 24th 2022.

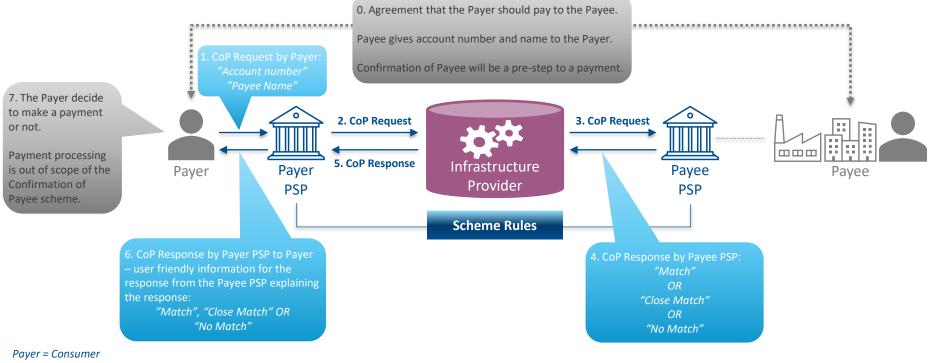

Confirmation of Payee flow – single request Consumer - instant 24/7/365




Payee = Account holder
